

Smoke-Free Public Housing Authorities/Commissions in New York State

This list was compiled through Smoke Free Housing NY, a network of community partners funded by the NYS Tobacco Control Program, and through a survey conducted April – June 2012 by Siena Research Institute. The following public housing authorities in New York State have a no-smoking policy for some or all of their apartment buildings. Some of the smoke-free policies grandfather current residents who are smokers for as long as they remain living in their apartment unit, therefore transitioning to being totally smoke-free. Most have applied a no-smoking policy to all residents and are already completely smoke-free.
